Incident Response Plan Preparation

Once the IR Plan has been reviewed and agreed within the business a table-top exercise will be scheduled and conducted onsite with the relevant stakeholder's present. Depending on the audience the exercise will have an executive or technical focus.

Incident Response Plan Execution

The exercise is often conducted in a conference or meeting room, either on-premises or a Covenco DR centre. A participant list is created for all relevant stakeholders and scheduled for a whole day. The exercise will start with an initial brief where participants are encouraged to work through the scenario using the injects when appropriate.
